

Automated Traffic Violation Enforcement System (ATVES)

Commercial Vehicle Height Monitoring System Camera Program

The Commercial Vehicle Height Monitoring System Camera Program uses a vehicle's height to convey to the monitoring system that the vehicle passing the camera is a restricted vehicle (over ¾ ton). When a restricted vehicle is detected by the system, photos and video are taken of the front of the vehicle, in order to capture the registration identification of the vehicle's cab. Commercial vehicle height monitoring system cameras are *operational 24 hours a day, every day of the year*, on posted (signed) streets.

Fines

Commercial Vehicle Height Monitoring System civil fines are listed below:

First Offense – Warning Second Offense – \$125.00 Third or Subsequent Offenses – \$250.00 each

Commercial vehicle operators should pay close attention to signs posted on city streets that restrict vehicles over ¾ ton, and familiarize themselves with the designated truck routes in Baltimore. The city's designated truck routes map is viewable at:

Citations may by paid by check or money order with the City of Baltimore Department of Finance, P.O. Box 13327, Baltimore, MD 21203, or by credit card online at https://pay.baltimorecity.gov or by phone at 410-396-4080. Failure to pay the civil penalty, request a review of the violation by the Local Designee (Ombudsman), or contest liability in a timely manner is an admission of liability, which may result in additional fees and penalties.

Permitting

If you have been issued a permit from the Maryland One System and received a citation during your permitted time of travel, please submit a copy of your permit along with a copy of the citation.

<u>Attention</u>: Please do not request a trial if you received a Commercial Vehicle Height Monitoring citation <u>and</u> have <u>one</u> of the following:

- 1. Bill of Lading,
- 2. Maryland One Permit, or
- 3. Proof of local delivery
